

Today, it is not only the oldest, but also the largest and – by any measure – the best law faculty in Slovenia.

The Conference will be held **within the Faculty of Law**: more precisely in the **Golden**, **Red** and **Silver Lecture Hall** (accessible via the main and the rear entrance, situated on the 1st floor of the new building – simply walk through the cafeteria and turn left towards the staircase leading you upwards).

Signs and support will be on hand to guide you to the halls and conference rooms.

<u>Means of Public transport</u>: no parking is available at the venue, thus we recommend using public transportation, coming on foot or using a nearby car park.
